



## **NET-ZERO INDUSTRY ACT PROPOSAL**

#### Joint UPEI-FETSA Statement

UPEI, the voice of Europe's independent fuel suppliers, and FETSA, the Federation of European Tank Storage Associations, welcome the publication of the Commission's <u>proposal</u> for a Net-Zero Industry Act ('NZIA'), as one of the main initiatives announced as part of the broader 'Green Deal Industrial Plan'.

In particular, we support the goal of strengthening the competitiveness of Europe's net-zero industry in the transition to climate neutrality, by creating more favourable conditions – both regulatory and investment-wise – for the expansion of net-zero technologies in Europe.

# In this paper, we wish to focus on one of the key aspects to make the NZIA operational, namely the scope and definition of net-zero (strategic) technologies.

We appreciate the Commission's efforts to calibrate the boundaries of the definition in Article 3(1) - i.e., to avoid final technological products being considered in isolation from their respective upstream components and specific production machinery.

However, in the context of the upcoming negotiations on this legislative proposal, we recommend that policymakers in the European Parliament and Council give priority to the following elements:

- support the Commission's proposal, which rightly recognises the importance of **renewable fuels of non-biological origin (RFNBOs) and carbon capture, utilisation, and storage (CCUS) technologies**, in the definition of 'net-zero technologies' provided in Article 3(1).
- Include sustainable alternative fuels technologies in the same definition but limited to fuels used in maritime transport and aviation; sustainable alternative fuels for road transport should also be covered as a critical measure to implement the G7 mandated reduction in emissions from the global vehicle fleet.
- Reconsider the exclusion of sustainable alternative fuels, CCUS and RFNBOs from the 'strategic' list of technologies (Annex). As powerfully illustrated in the "Fit for 55" agreements, the EU will rely on these technologies for the decarbonisation of transport and other economic sectors, notably energy intensive industries.
- Similarly, include in the list of 'net-zero' (Article 3) and 'strategic net-zero' technologies (Annex) logistics such as storage and distribution of sustainable energy carriers, and not limit upstream components and machinery.
- Although 'battery/storage technologies' are labelled as 'strategic' net-zero technologies (Annex), the inclusion of the storage sector is too ambiguous: include storage terminals as part of this item in the Annex given their mission critical role in the logistics and supply security of net zero technologies.

UPEI and FETSA stand ready to contribute constructively to the debates on this file. To this end, we have included our concrete proposals for amendments on the above-mentioned priorities in the Annex.





### **ANNEX: Suggestions for amendments**

#### AM 1 - Art. 1 (new)

Text proposed by the Commission	Suggestion for AM

#### Justification

Due to fast technological innovation and developments, it is essential to periodically review and adjust the scope of technologies falling under the scope of this Regulation. If successfully implemented, regulatory sandboxes should bring faster new net-zero technologies to market deployment maturity. A successful climate transition requires the decarbonisation of industry as a whole rather than certain sectors "only".

#### AMs 2, 3, 4 – Article 3(1)

#### Justification

The definition of 'sustainable alternative fuels' should not be limited to fuels used in the maritime and aviation sector. The definition should also include renewable and low-carbon liquid fuels used in the decarbonization of road transport, as a sector responsible for one fifth of the total GHG emissions in the EU. The inclusion of 'alternative fuels for zero-emission vehicles' and 'renewable fuels' also ensure coherence with other 'Fit for 55' key legislative developments including Regulation 2023/851 on CO2 emission performance standards for new passenger cars and new light commercial vehicles, and the revision of the Renewable Energy Directive.

The definition of 'net-zero technologies' should include logistics technologies such as distribution and storage of sustainable energy carriers, including but not limited to tank storage terminals, which provide an essential link in the supply chain for energy carriers.

## AM 5 – Art. 3(1)

### Justification

The successful decarbonisation of Europe cannot be achieved without a recognition of interdependencies between value chains. Therefore, the deployment of net-zero technologies and value chains making use of these technologies must be under the scope of this Regulation for 'net-zero strategic projects' and for 'net-zero technology manufacturing projects'.

The introduction of 'deployment' in the definition of 'net-zero technology manufacturing project' in Art. 3(1) must be applied consistently in the Act i.e., in articles 3.1(f), 3.1(g), 3.1(h), 4.1, 6.1(a) and (b), 6.2, 8.1, 8.2, 10.1(a) and (b), 10.2, 10.4, 37.1, 37.2, 37.3, 37.4. In addition, the operationalisation and impact of introducing 'deployment' in the Act should be subject to further work.





# AM 6 – Art. 8(1)

### Justification

Not only the project itself is important. All the necessary infrastructure like pipelines and tank storage terminals, should be included in the planning.

#### Justification

Coherent with the proposed amendment to the definition of 'net-zero technologies' in Art. 3(1), the storage of sustainable energy carriers should also be seen as a net-zero strategic project.

Tank storage terminals provide an essential interface between sea, road, rail, inland waterways, and pipeline logistics in the supply of energy carriers, chemicals, animal feeds and fats, oils and other substances, helping to balance out supply and demand and ensure companies and consumers have access to these products.
